## Registration Sessions

### The registration schedule for the LWSC 2012 Winter Registration

Registration is from **8:30am--5:00pm** each day.

- *Monday January 23, 2012, Center is closed to prepare for Registration*
- *Tuesday January 24, 2012, Registration for all Classes*
- *Wednesday January 25, 2012, Registration for all Classes*
- *Thursday January 26, 2012 Registration for all classes*
- *Friday January 27, 2012, Registration for all classes*
- *First day of classes, Monday January 30, 2012*
- *Last day of classes, Friday March 23, 2012*

The gates to the facility will open at 7:30am and the shuttle bus will operate continuously as needed. Considerate of safety, **please do not park on Panola Road**. You will be able to register for any class requiring registration and will not be required to come back to register for another Corridor. The Billiard Room will be opened during registration. Breakfast and Lunch will be available during registration at the normal times.

Members will receive one (1) schedule per quarter during registration as supplies last. The schedule will be posted around the facility and is available for download on letter sized (8.5x11 in.) format from the DeKalb County website at [www.dekalbcountyga.gov](http://www.dekalbcountyga.gov) as a pdf file. Only new members will receive a hard copy of the schedule following registration.
