

NOTICE

All positions are subject to a background check. If you have **EVER** been convicted of a crime against the law or have pending charges, excluding a minor traffic violation or a conviction discharged under Georgia's First Offenders Law, make sure you list those charges on your application.

Note: A conviction does not automatically exclude you from consideration for employment.

Failure to note a conviction on your application may result in automatic **DISQUALIFICATION** of employment with DeKalb County Government. Also, employment for current DeKalb County Employees who fail to note a conviction on their application could result in suspension and/or termination.

Candidates Applying for Positions Requiring Commercial Driver's License (CDL)

State and Federal Regulations *require* that you provide us with the following information on your application:

- The names and complete addresses of all previous employers for whom you have driven a commercial vehicle in the last ten (10) years.

Description of a commercial vehicle:

- A commercial vehicle is a vehicle designed to carry 15 or more passengers;
- A vehicle whose GVWR is 26,001 pounds or more;
- A vehicle which towed a trailer with a GVWR of 10,001 pounds or more;
- A vehicle used to transport hazardous materials requiring a placard.
- Dates of each employment.
- The reason for leaving current or past positions.

Note: Comments such as "personal" or "will explain in the interview" are **NOT** acceptable.

If the requirements listed above are not followed, the application may be rejected or returned to the applicant.
